## **Access to our website and interference with its functions**

## **Transfer of tickets**

## **Refunds**

## **Photographers**

Photographers and videographers must wear in-game clothing during Krigslive unless otherwise agreed.

- The photographer must send a selection of their photos/videos to Krigslive (**krigslivedk@gmail.com**).
- The photographer allows Krigslive to share the photos/videos digitally and/or in print for the purpose of promoting Krigslive or events related to Krigslive (non-commercial use).
- The photographer allows private individuals to share the photos/videos, provided the photographer is credited and the use is non-commercial (e.g. as a profile or cover image).
